### H.E. Christelle Sohun

#### High Commissioner for Mauritius to Australia



Ms Sohun was appointed as Mauritius High Commissioner to Australia in 2017 with non-resident accreditation to New Zealand. Ms Sohun has a strong background in law, holding a Bachelor of Laws with Honours from the University of Wolverhampton, a Postgraduate Certificate in Law of International Trade from the University of Wales and a Post graduate Diploma in Professional and Legal skills from Inns of Court, School of Law, City University, London.

Ms Sohun was called to the Bar of England and Wales in 2006 and to the Bar of the Republic of Mauritius in 2010. She is a member of the Honourable Society of the Middle Temple Inn. She practised as an independent Barrister until December 2016 when she took employment as Legal Executive at Harel Mallac Group. Ms Sohun was also a board member of the Financial Intelligence Unit and a member of the Independent Review Panel in Mauritius.

#### High Commissioner for Australia to Mauritius



Ms Dee was appointed as Australia's High Commissioner to Mauritius in July 2017 with non-resident accreditation to Comoros, Madagascar and Seychelles.

Prior to her appointment, she held a range of positions in Canberra for the Department of Foreign Affairs and Trade, including director of the external budget section. She also served at Australia's missions in Jakarta, Indonesia, as the Australian Embassy spokesperson and manager of public affairs, and in Harare, Zimbabwe. Ms Dee holds a Master of Arts (Foreign Affairs and Trade) from Monash University and a Bachelor of Business (Journalism) from the Queensland University of Technology. She is married with two children and enjoys travel, music and learning to scuba dive in Mauritius.
